Directive on the Prevention from Sharp Injuries in the Hospital and Healthcare Sector (2010/32/EU)

Aim: To protect Europe's healthcare professionals and workers from potentially dangerous infections due to injuries with needles and other sharp medical instruments.

➡ **Implementation is important!**

Clause 5 – Risk Assessment

Clause 6 – Elimination, Prevention and Protection

Clause 7 – Information and Awareness-raising

Clause 8 – Education and Training

Clause 10 – Response and Follow-up



EFN Survey on the implementation of Directive 2010/32/EU



- ✓ 7.000 health professionals from 28 EU Member States
- ✓ 95% nurses
- ✓ 41% suffered from sharps injury

**Areas for improvement:
Education - Risk Assessments - Ban of
Recapping - Awareness Campaigns**



EFN Survey on the implementation of Directive 2010/32/EU



The majority of incidents can be **avoided** using a **combination** of education and **training**, safer working practices, risk assessment and medical technology.

Mixed approach reflected in Directive 2010/32/EU!

Directive 2013/55/EU



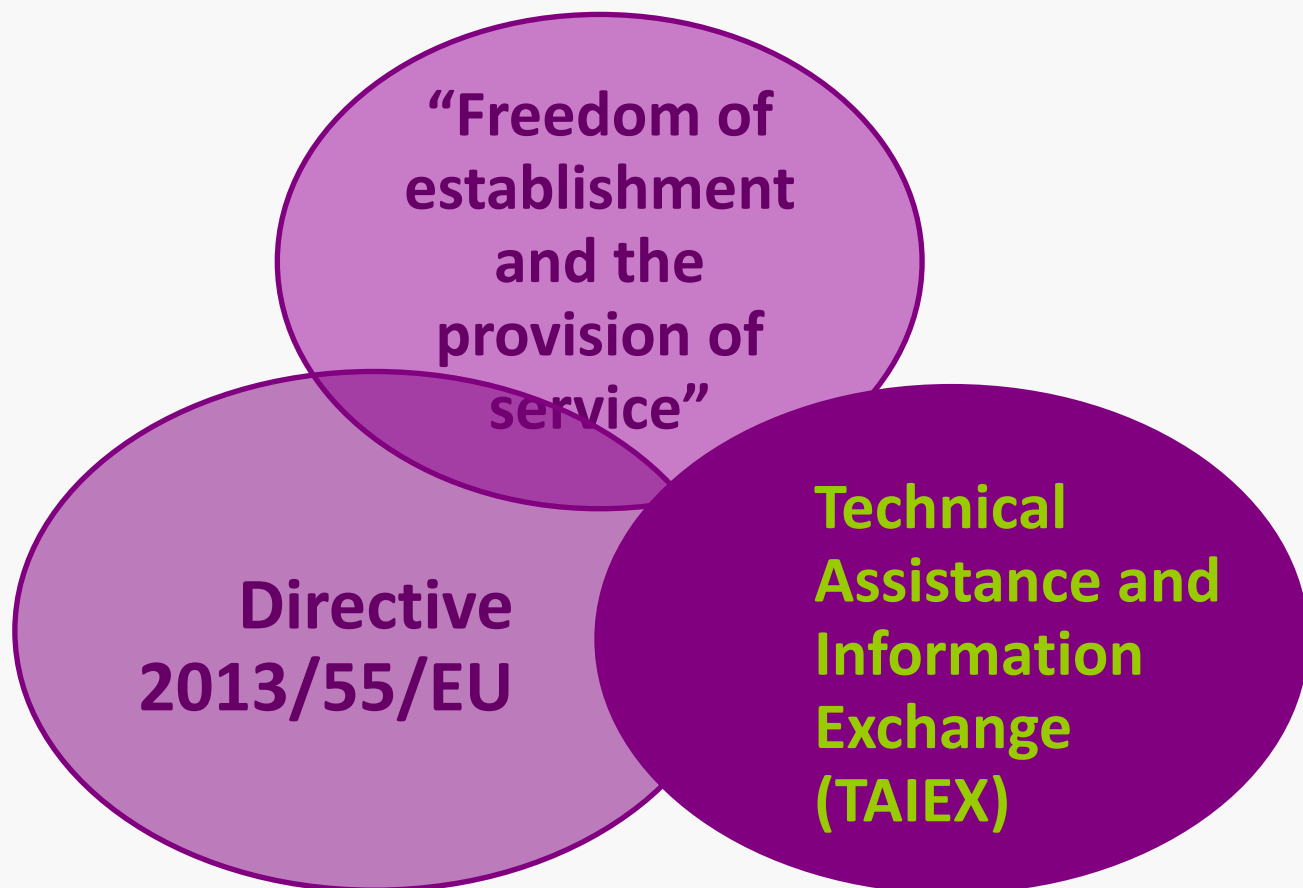
1. Independently diagnose, plan, organise and implement
2. Cooperate with other players from the health sector
3. Empower patients towards a healthy lifestyle & self-care
4. Independently initiate measures to save lives
5. Independently advise, instruct and support
6. Ensure the quality of nursing care
7. Communicate comprehensively and cooperate with members of other professions in the health sector
8. Analyse the quality of care
